GENERAL

AVAILABILITY

Delivery of all our items is determined by our choice for the fastest possible delivery. Delivery time varies depending on product availability, however, if product is available, it will be shipped to the address stated within 3-5 days of receipt of payment. In the event that there is a delay in delivery, the customer will be informed of the reason for the delay and the new estimated delivery time. If the customer does not accept the new delivery time the customer is entitled to cancel the purchase.

SUPPLY RISK

electroCore assumes the risk of damage or loss of the goods during shipment from the warehouse to the customer. In case of return of goods, the customer is responsible for the risk of damage or loss.

PRICES

Prices subject to change. Price does not include federal (GST, HST) or provincial sales tax.

PAYMENT

RIGHT OF WITHDRAWAL
